

Fast Lane Rewards® Win Free Gas Sweepstakes Official Rules

2. **ELIGIBILITY:** Only open and offered to legal U.S. residents who reside in Michigan and who are 18 years of age or older at the time of entry and who are, or who register to become a Fast Lane Rewards member with a valid email or phone number on file (“Contestant”).
